Entries Open August 16, 2010 and close September 4, 2010

Trial Limits: Friday: Combined total of Farm & Arena Trial not to exceed 40 runs maximum. Farm Trial 9 Total Runs (8 head hair sheep). Arena Trial combined 31 runs not to exceed 12 sheep (3 head hair sheep), 15 cattle (3 head Hereford) & 20 duck (5 head Blue Swede/Buff). If Farm Trial does not fill, more sheep runs may be added. Saturday: Trial #1 and Trial #2 will offer 7 cattle, 14 sheep, & 10 duck runs each. Sunday: Total 15 cattle, 27 sheep, 20 duck.

Trial Schedule: Handler's Meeting: 7:30 a.m. all three days. Friday: Farm Trial immediately following Handler's Meeting. Arena Trial following Farm Trial starting with cattle, sheep, ducks. Saturday: Trial will begin immediately following Handler's Meeting. All Cattle will be run first. Sheep and ducks may be run concurrently after all cattle runs are complete. Sunday: Cattle will begin following Handler's Meeting. Sheep and ducks will run concurrently after completion of cattle. Run Order for all three days is Advanced, Open, Novice, Started, Junior.

Entries: Trial is pre-entry. Entries will be accepted by post-mark date. Entries post-marked before the opening date of August 16 or after closing date of September 4 will be returned unopened. A waiting list will be made if the run limit is exceeded. Day of trial entries will be accepted if our trial limit is not reached. Bitches in season will run in order but must be kept away from the trial arenas before & after their run. Please notify the course director if you are trialing a bitch in season. Novice & Junior Handling runs count toward total run limits. Order of run will be by random draw prior to the trial.

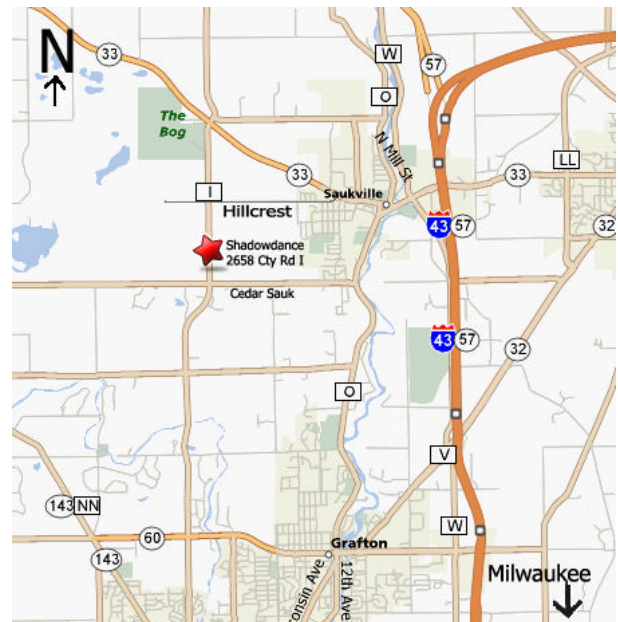

DIRECTIONS: Shadowdance Farm is located at 2658 CR I on the east side of County Road I in the town of Saukville, between Hwy 60 (to the south) and Hwy 33 (to the North).

From the southwest: Hwy 60 east towards Grafton. North on Hwy I 3.25 miles.

From the northwest: Hwy 33 east towards Saukville. South on Hwy I approximately 1.5 miles.

From Hwy 43 either direction: Exit Hwy 33/Saukville west. Hwy 33 through town approximately 1 mile. Hillcrest Road is angled off Hwy 33 on the left, ½ block after the last set of lights (Citgo station on that corner). Left on Hillcrest to Hwy I. Left on I approximately ½ mile.

Farm Trial Course

Sanctioning Pending

The sheep have been grazing in the field and it's time to bring them in, sort off some 6 month old lambs, and load the moms into the trailer. Below are your instructions, course layout is on the following page. Farm trial requirements are as follows: Pen work with a minimum of two pens, a sort of at least 3 marked animals, chute work, a gather, and two Other tasks which in our course are a hold and loading into a trailer. Good luck to all. ✍

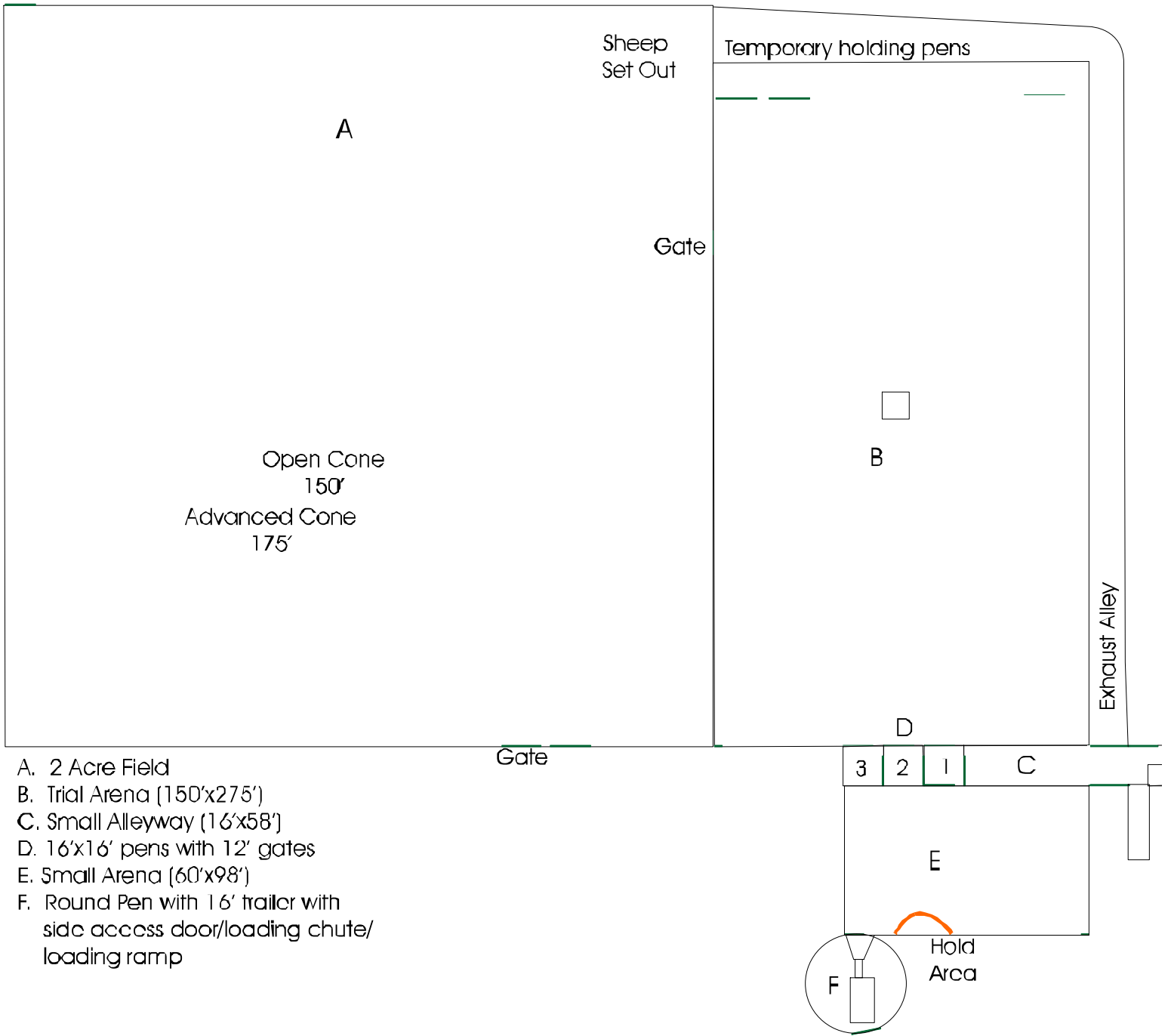
Run begins when dog is sent on gather.

1. Gather 8 head of sheep from field A and bring through gate and across arena. **Open:** Handler must send their dogs from Cone 1 but may position themselves ½ way between the dog and the stock **Advanced:** Handler must send their dog from Cone 2 Gate 1 will be closed at the beginning of the run and should be closed once the sheep enter the arena. **Gather Requirement 25 pts.**
2. Sheep should be taken through Pen 1 and loaded into Pen 2. **Pen Requirement 25 pts. (in conjunction with pen work on #7)**
3. Sort three marked lambs into Pen 3, five unmarked ewes into Pen 1. **Sort Requirement 25 pts.**
4. Take ewes from Pen 1 across Arena E to Marked Holding Area. Hold stock for 15 seconds or until Judge calls "that's a hold". **Open:** Handler may assist dog in placing stock in Holding Area (i.e. by fetching stock) and may stay with stock, or beside dog for hold. **Advanced:** Dog must drive stock to Holding Area. Handler must remain behind dog or at Gate 3 for length of hold and must stay at Gate 3 while dog gathers stock from Holding Area. **Other Requirement: Hold 15 pts.**
5. Ewes must be moved through Gate 3 and into Loading Chute. **Open:** Handler may close Gate 3 to prevent sheep from backing out of Loading Chute area. **Advanced:** Gate 3 must remain open while loading sheep. **Chute Requirement 25 pts.**
6. Load sheep into trailer and close door. **Other Requirement: Trailer 15 pts.**
7. Unload sheep from trailer, move across Arena E back to Pen 1. Move lambs from Pen 3 to Pen 1 with ewes. Move all sheep through small alleyway and exhaust up main alleyway. **Pen Requirement 25 pts. (in conjunction with pen work on #2)**

Run ends when alleyway is closed.

Maximum time allowed: 30 minutes. There will be a 10 minute and 3 minute warning.

Tie Breaker: In event of a tie, the Sort will score will be used to determine placement.
